Instructions for Form 1040NR-CM-X (2024) Amended CNMI Nonresident Alien Income Tax Return

PART A Combined Due or Overpayment

- 1. Enter the amount from line 3 of the amended return.
- 2. If the amount on line 3 of Form 1040NR-CM original return or previous amendment is greater than zero, enter the amount actually paid as a negative number. Otherwise, enter zero.
- 3. Enter the amount from line 3 of Form 1040NR-CM original return. If the amount is less than zero, enter the amount refunded as a positive number. Otherwise, enter zero.
- 4. If the sum of lines 1, 2 and 3 is greater than zero, enter the result here. Otherwise, enter zero.
- 5. If the sum of lines 1, 2 and 3 is less than zero, enter the result here as a positive number. Otherwise, enter zero.
- 6. Enter the amount on line 5 you want credited to your 2025 tax return, but not more than the amount on line 5.
- 7. Subtract line 6 from line 5.

PART B Additional Child Tax Credit
